COMMITTEE ACTIONS:

Your committee met in an Executive meeting on Wednesday, February 24, 2023 around 1:30 pm to deliberate on this nomination.

On this meeting, your committee decided to hold public hearings and to solicit public hearings regarding this nomination.

During the public hearing, the Governor of the Kosrae State had mentioned the interest and willingness of the nominee to serve our state as a Director. As the committee met with the Acting Director, Division Heads, and the employees, the committee noticed the present employees agreeing or in full support for the nominee. During the last session of the public hearings, the mayors were in full support for the nominee.


RECOMMENDATION:
